1. **CATALOGUE FEE** must accompany consignment form. All other fees will be deducted from your check. 8% commission or \$40 minimum 2 yrs & older, \$30 minimum weanlings/ yearlings. Pass out fee 1% of last bid OR \$40 minimum- 2 yrs & older, \$1% of last bid OR \$40 minimum weanlings/ yearlings, miscellaneous fees: **Yardage/Ins.** - \$3.50, **Vet Inspection** - .50, **Vet Consultation** - .50, **Halter/Lead Rope (to go with horse)** - \$2.50. **Sorry – NO Substitutes** if unable to bring the horse.
2. **ORIGINAL REGISTRATION PAPERS & SIGNED TRANSFER** with consignment form and consignment fee **MUST** be received to catalogue your horse.
3. **SELLER ACCEPTS** and assumes responsibility on bids not honored & on any printer errors in catalogue listings.
4. Horses are catalogued **IN THE ORDER** consignments are **RECEIVED** in the office.
5. **HEALTHS & COGGINS** –All **OUT-OF-STATE HORSES** must bring a 30-day or health certificate the **day of the sale**. All out-of-state horses **EXCEPT** those from Nebraska, Montana and North Dakota require a 12-month or less, negative Coggins test for shipment to South Dakota. Buyers requiring a Coggins test for interstate travel can have done by our on-premises vet for \$25. **PLEASE NOTE IN YOUR COMMENTS IF YOUR HORSE IS COGGINS TESTED & bring or send Coggins tests separately to office.**
6. **CHECKS** for all catalogued horses will be in the mail five days after the sale.
7. If for some unforeseen problem, you are unable to bring your consigned horse to the sale, you will be assessed a **\$150.00 “NO SHOW” FEE**. This fee will be credited on your selling commission if the same horse is re-catalogued within the next several months.
8. Horses must be **GUARANTEED SOUND** unless stated otherwise in the comments.

9. Transfers: - Please read carefully! We DO NOT skip transfers. If registration papers are not in your name, we will accept the papers only if the transfer to you is filled out in its entirety, with your address and date of purchase. A new transfer signed by you must be attached to first transfer and a \$15 check made payable to correct breed association must accompany it (APHA or AQHA).
